## **RE: NOSB Materials Committee - Discussion Documents on Extractants and Solvents and Significant Residues Definition in Classification of Materials Policy**

Dear Members of the National Organic Standards Board,

Thank you for your continued work to clarify and improve the procedures and policies by which the NOSB conducts its business. Wolf, DiMatteo + Associates (WDA) appreciates the opportunity provided through public comment to participate, as a stakeholder, in the unique National Organic Program public/private partnership.

The NOSB and the stakeholder community, including an ad-hoc Materials Working Group, have for over seven years, worked to advance a policy on the Classification of Materials. In 2010 the NOSB approved a Classification of Materials recommendation that is currently under consideration by the NOP. The issues raised in these two Materials Committee discussion documents are linked to the Classification of Materials recommendation therefore WDA believes that further discussion on these issues should be postponed until the NOP releases a draft Classification of Materials policy. It is our opinion that a more productive discussion and response from stakeholders will occur when there is a NOP draft policy on the Classification of Materials. Otherwise this will be another endless round of debate without resolution or action. WDA urges the NOP to release a draft policy on the Classification of Materials as soon as possible so that progress can be made toward consistent review of materials by the NOSB, Materials Review Organizations, and certification agents.

WDA recognizes the extensive work done by the Committee to draft its discussion document. However, WDA is not submitting answer to the questions posed in the discussion documents at this time. Instead we direct the NOSB to the Organic Trade Association's comments and answers which WDA fully supports.
